Answers:

Q1=B

In the Netherlands you can receive a sentence from the age of twelve if you are suspected of something that is not allowed under criminal law. Think of a community service or a learning order, to repair damage or improve behavior. It is important that it is always considered which punishment is best and that a severe punishment is not immediately chosen. This is because the special rules of juvenile criminal law apply to young people, whereby it is paramount that lessons can be learned from mistakes. That is why young people in the Netherlands do not often receive a prison sentence. Especially not for stealing a game.

Q2 = A

As a child you are allowed to do chores for a fee, such as washing a car or doing the dishes. That is not child labor. However, you are not allowed to do work a) that is bad for your health, b) that prevents you from going to school or c) that requires you to give the money to your parents or another adult. In the Netherlands you can have a job from the age of thirteen, but not much work yet.

You have the right to live with your parents. That is best for you in most cases. That's why you can't just be separated from your parents. Even if your parents can no longer pay the rent. The municipality must provide a replacement place to live if your parents cannot arrange this themselves.

Q4=A

The correct answer is A. Children with disabilities have the same rights as all children. Only they have more difficulty in moving and sometimes certain activities are more difficult. Nevertheless, these children must lead a life as normal as possible and therefore be able to attend a regular school. Schools must be adapted in such a way that children with disabilities are also welcome.

Q5 = C

There are differences between cultures about what constitutes a good parenting, but you should never be beaten. Not even by your parents. According to the Convention on the Rights of the Child, as a child you must be protected against child abuse, and beating is a form of child abuse.

Q6 = B

You have the right, like all other children in the world, to the best possible health and healthcare. Even if you have fled to the Netherlands and do not yet have the necessary papers to be able to go to hospital. Nobody should be refused. Yet not all children receive the same care yet.
